## Singapore Convention on Mediation

An exploration of the impact and scope of the Singapore Convention in the global mediation landscape. The Singapore Convention on Mediation marks a major step forward in elevating mediation as a trusted method for resolving cross-border commercial disputes. By enabling the direct enforcement of mediated settlement agreements in national courts, it addresses a long-standing gap and brings mediation closer in reliability to arbitration. As more countries adopt the Convention, it is reshaping how businesses approach conflict—encouraging solutions that are faster, more cost-effective, and relationship-driven. Beyond its legal framework, the Convention signals a global shift toward collaboration over confrontation, positioning mediation as a central pillar of modern dispute resolution.

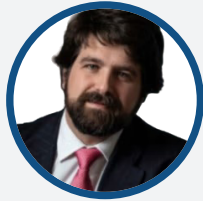
